THE UNDERSIGNED INCORPORATION FOR THE PURPOSE OF FORMING LAHASSEE, FLORIDA CORPORATION UNDER THE FLORIDA NOT FOR PROFIT CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION.
