ARTICLE I NAME

The name of the Corporation shall be:

ARTICLE II PRINCIPLE OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- A. The Corporation is organized exclusively for charitable, educational, religious, or specific purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.
- B. To provide a residential home for needy boys, to enter into, perform and carry out contracts and agreement of every kind and nature, with any person, firm, corporation or other entity, and any state, country, municipal or other governmental body, including all boards, bureaus and agencies thereof. To carry on any other activities necessary to, in connection with or incidental to the foregoing.
- C. INUREMENT OF INCOME: No part of net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered.
- D. OPERATIONAL LIMITATIONS: Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions, to which are deductible under section 170(c)(2) of the Internal Revenue of 1986 (or the corresponding provision of any United States Internal Revenue Law)

ARTICLE IV MANNER OF ELECTION

The directors shall be appointed initially by the incorporators and appointed each year by the then serving board of directors.

Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such, purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
