

Pursuant to the provisions of section 6\(\)7.1006, Florida Statutes, this Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST:

Amendment adopted: Change of Initial Board of Directors

ARTICLE 4

The corporation shall not have members. The affairs of the corporation shall be conducted by the board of directors of the corporation. The method of election of directors shall be stated in the Bylaws of the corporation. The corporation shall have a minimum of three (3) directors. Amendment Adopted: <u>Dissolution of Corporation</u>

ARTICLE 6

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, distribute all of the assets of the corporation to organizations organized and operated exclusively for charitable, religious, or educational purposes under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

THIRD: The date of adoption of the above amendment is December 2, 2012.

FOURTH: The amendment was adopted by a unanimous vote of the board of directors.

FIFTH: There are no members entitled to vote in this organization.
