**Articles of Incorporation
Of
The Florida Historical Preservation Restoration Society Inc.**

Articles of Incorporations of the undersigned, of which all are citizens of the United States of America, desiring to form a Nonprofit Corporation under the laws of Florida, do hereby certify:

Article 1: The name shall be The Florida Historical Preservation Society Inc.

Article 2: The initial place in Florida where the principle office of the said corporation is to be located in the city of **DeLand (Volusia County) Florida, in the United States.**
226 E. Howry Avenue, Deland Florida 32720

Article 3: The said corporation is organized for charitable, educational, religious, scientific purpose and other activities. This corporation, shall qualify as a 501 (c) (3) of the Internal Revenue Code, or corresponding sections of any future tax codes. The purpose of the corporation will be to provide funding, for projects involving buildings deemed historic, assist in the preservation process of buildings deemed historic, to maintain a historical publication, to put on history related workshops and to help organizations register their buildings as historic sites, to hold monthly forums on topics historical in nature, and other historic project approved by the board of directors.

Article 5. No part of the net earnings of this corporation, shall insure to the benefit of or be distributed to its members or other private persons, except that the said corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments for lease or rental equipment and distribution in furtherance of the purpose set forth in Article 3 hereof. No part of activities of the said corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. The said corporation shall not participate in, or intervene in any political campaigns on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles. The said corporation shall not engage in any activity or exercise any powers that are not in furtherance of the purpose of the said corporation.

Article 6. Upon dissolution of the said corporation, assets shall be distributed for one or more exempt purpose within the meaning of Section 501(c) (3) of the Internal Revenue Code, or the corresponding section of future federal tax codes, or shall be the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the State of Florida or local government for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of Volusia County or in the county which the principle office of the said corporation is located, exclusively for such purpose or to such organizations, as said Court shall determine which are operated exclusively for such purpose.
