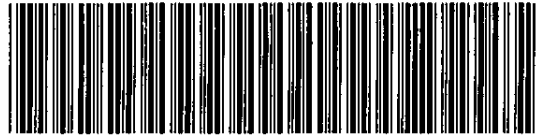

**ARTICLE I      NAME**

The name of the corporation shall be:

New Life School of Theology, Inc.

**ARTICLE II      PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

3303 Country Club Blvd. Cape Coral, FL 33904-4952

**ARTICLE III      PURPOSE**

The purpose for which the corporation is organized is:

- A) As a Christian School, this corporation is organized exclusively for charitable religious and educational purposes within the meaning of section 501 ( c ) ( 3 ) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- B) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes set forth herein.
- C) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office.
- D) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by:
  - 1) by an organization exempt from federal income tax under section 501 ( c ) ( 3 ) of the Internal Revenue Code, or by the corresponding section of any future tax code, or,
  - 2) by an organization contributions to which are deductible under section 170 ( c ) ( 2 ) of the Internal Revenue Code, or by the corresponding section of any future tax code.
- E) Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to an organization which is organized and operated for one or more exempt purposes and has established its exemption under section 501 ( c ) ( 3 ) of the Internal Revenue Code, or the corresponding section of any future tax code.
