Article Seven

Code of Bylaws; Indemnification; Amendments of Articles

Section 7.01. Code of Bylaws. The Board of Directors of the Corporation shall have the power to make, alter, amend, or repeal the Bylaws of the Corporation, subject to the restrictions that a majority vote of the Directors is necessary to take these actions.

Section 7.02. Article Eight

Limitation on Activities

Section 8.01. Limitations. No part of the net earning of the Corporation shall inure to the benefit of, or be distributable to its member, trustee, officer, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services render and to make payments and distributions in the furtherance of the purpose set forth in Article Two hereof. The corporation shall not participate in, or intervene in (including publishing or distribution of statements) any political campaign on behalf of or in the opposition to any candidate for public office. Not withstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation except from federal income tax under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article Nine Dissolution

Section 9.01. Dissolution: In the event of dissolution, either voluntary or involuntary, assets shall be used to pay debts and liabilities of the corporation. Any remaining assets shall be distribute for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. A Court of competent shall dispose of any such assets not so disposed. Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization as said Court shall determine, which are organized and operated exclusively for such purposes.

Article Ten Non-Stock

Section 10.01. Non-Stock Basis. This corporation shall be organized upon a non-stock basis.
