

Article III of the Articles of Incorporation is amended to read as follows:

"The purpose or purposes for which the corporation is organized is to provide and administer an international student exchange program under the auspices of Rotary Clubs throughout the world and under and within the Rotary International Model Program for Youth Exchange. The organization is organized exclusively for charitable, religious, educational and scientific purposes under section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code. The organization's assets are permanently dedicated to the foregoing purposes. Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. No part of the earnings, if any, of the corporation shall inure to the benefit of any private shareholder, member, or individual, and no substantial part of the activities of the corporation shall be the carrying on of propaganda or attempting to influence legislation


