



This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. *This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to organize charity events, social events, and community activities in order to raise funds for those families and children in need in our community. The goal of the organization is to lead these people and children in need towards a better life, improved happiness, in addition to rebuilding their material lives or improving their living and educational conditions. Through the events coordinated the funds will be used to provide nutritious food, shelter, electricity, toys, educational items and assistance, and financial aid to those families who are in need. The purpose of the charity is to show that generosity, kind hearts, and caring people are not lost in today's society. That people can pay it forward in order to receive joy and satisfaction, and that selfless acts go rewarded. Examples of contributions could include a family in need telling us about their story and the foundation being able to help them pay their electric or water bill, or children or adults in need writing in or contacting us and telling us what they would like to receive or need assistance with. I had someone who knew that we were beginning yesterday who contacted me, her mother has passed away, her sisters were split up, and due to the lack of funds she was evicted from her home. This is the perfect example of a woman that the foundation will help, it is my goal to use the funds that we are able to raise to help her with a security deposit to find a new home, and to assist her in finding a part time job in order to help pay her bills. The foundation will have the capability to help not only better the lives of those who need it, but also to help them learn how to better themselves and provide a better future..*

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

All references to sections of the Internal Revenue Code shall include such sections as of the date hereof and the corresponding section of any future federal tax code.
