Pursuant to the provisions of section 617.1006, Florida Statues, this Florida Not for Profit Corporation adopts the following amendments to its Articles of Incorporation:

ONE: The name of this corporation is **The Girls of Valor Community Choir of St.**Lucie County

TWO: The principal office address and mailing address is:

3210 North 25th Street

Fort Pierce, FL 34946

THREE: The Specific purpose for which this corporation is organized is:

Train girls from underprivileged socioeconomic settings in living skills. To develop an excellent, well disciplined Girls choir, while also Equipping these young women with personal, academic and social skills to allow them to become more productive members of the community and to motivate them for success. "Young Women of Valor, Pursuing Excellence, and being a Vessel of Honor". Utilizing local, state and federal funding, donations, investors, loans and grants to provide Academic assistance, housing, community and Economic Development for the poor and homeless, youth building and mentorship and drug elimination. Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax

code. No part of the net earnings of the organization shall inure the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for series rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue code, or corresponding section of any future federal tax code.

Upon dissolution of the organization, the Board shall after paying and making provisions for payment of all liabilities of the organization, shall distribute all assets for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code or shall be distributed to the federal government, or to a state or local government, for public purposes. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
