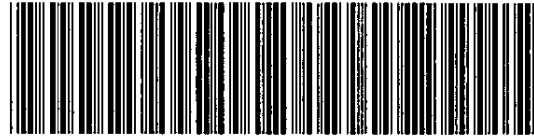

## **Article 1 Name**

The name of the corporation shall be: North Port Area Women's Club Incorporated. A not for profit corporation.

## **Articles II Principal Office**

The principal place of business and mailing address of this corporation shall be:

## **Articles III Purpose**

The purpose for which the corporation is organized is: Increase involvement and enhance networking among women of all ages. To support charitable activities and promote volunteerism. To provide educational scholarships and special awards. Foster individual's potential and develop skills for future success. Advance awareness of women's issues within our community.

North Port Area Women's Club Incorporated is organized and operated exclusively for exempt purposes set forth in section 501 (C) 3. None of its earnings inure to any private shareholder or individual. North Port Area Women's Club Incorporated will not participate in any campaign activity for or against political candidates or future success.

#### **Articles IV Manner of Election**

The manner in which the directors are elected or appointed: Only active members in good standing (paid dues) are eligible to serve as a chairwomen. Any member of North Port Area Women's Club Incorporated who has been a member for 2 years or more and has served on a committee for at least one year is eligible for nomination to the Board of Directors. A Nominating Committee of at least three members shall be elected annually concurrent with the slate of directors and Standing Committee Chairpersons. The Nominating Committee shall present a slate of one or more nominees for each office to the Board of Directors at the October BOD quarterly meeting. Nominations may also be made from the floor. The election of directors and Standing Committee Chairpersons shall be held at the October regular membership meeting.




