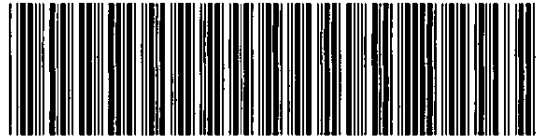

A 2/3 vote of board members present is required to receive or reject the nominee.
