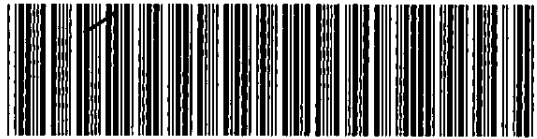

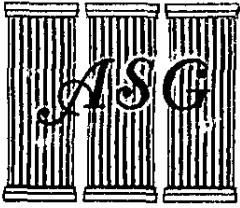



**ARTICLES OF INCORPORATION
OF
COMINGHOME.ORG, INC.**

In compliance with the requirements of Chapter 617, Florida Statutes, the undersigned, all of whom are residents of the State of Florida and all of whom are of full age, have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

ARTICLE I

NAME

The name of the corporation is ComingHome.Org, Inc., hereafter called the "Organization".

ARTICLE II

PRINCIPAL OFFICE

The principal office of the Organization is 1108 Middle Drive, Fort Walton Beach, Florida 32547. The mailing address of the Organization is P.O. Box 4425, Fort Walton Beach, Florida 32549-4425.

ARTICLE III

REGISTERED AGENT

Sharee Ayotte, whose address is 1108 Middle Drive, Fort Walton Beach, Florida 32547, is hereby appointed the initial registered agent of this Organization.

ARTICLE IV

PURPOSE AND POWERS OF THE ORGANIZATION

Said Organization is organized exclusively for charitable, religious, educational,

and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the Organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the Organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Organization shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

This Organization does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are to provide for the administration and construction of homes for certain disadvantaged groups and to exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of Florida by law may now or hereafter have or exercise.

ARTICLE V

BOARD OF DIRECTORS

The affairs of this Organization will be managed and overseen by a board of directors and officers, who need not be members of the Organization. The number of directors may be increased by amendment of the By-Laws of the Organization. The names, titles, and addresses of the persons who are to act in the capacity of initial directors until the selection of their successors are:

At the first annual meeting, the members shall elect successors to the above stated initial officers and directors and then again at each successive annual meeting. The election shall be by a majority of the members.

ARTICLE VI

DURATION

The corporation shall exist perpetually.


ARTICLE VII

DISSOLUTION

Upon the dissolution of the Organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of

competent jurisdiction of the county in which the principal office of the Organization is then located, exclusively for such purposes or to such organization or organizations, as such Court shall determine, which are organized and operated exclusively for such purposes.

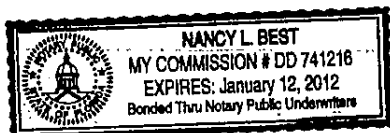
