## EMERALD WATERS OF FRANGISTA II OWNERS ASSOCIATION, SNC. FLORIDA A FLORIDA CORPORATION NOT FOR PROFIT

The undersigned incorporators by these articles associate themselves for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, and adopt the following articles of incorporation:

#### ARTICLE I. NAME

The name of this corporation is EMERALD WATERS OF FRANGISTA II OWNERS ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association", these articles of incorporation as the "Articles", and the bylaws of the Association as the "Bylaws".
