Article I: The name of the corporation is:

Article III: The purpose of the corporation:

**This is a religious institution, a church. It's purpose, therefore, by the assistance of the Holy Spirit, is to proclaim the gospel of our savior, Jesus Christ to the converting of souls; to provide a place of worship; to establish religious educational programs geared toward the lost, young and old; to provide a haven for spiritual rehabilitation and counseling; to offer assistance to the underprivileged, the elderly, the hungry, the naked and the homeless; and to promote spirituality.**

**We accept the Bible as the true Word of God. Through the anointing and guidance of the Holy Spirit, we seek to teach and preach everything that the bible teaches. Our doctrines are based on the Scriptures, and not on man-made traditions.**

Article IV: The manner of election:

**The Chief Officer is the Pastor/President, who is called by God to preach the gospel, ordained to the work of the ministry and accepted by the church to serve as its leader. The Pastor/President elects and appoints three - four (3-4) additional officers to serve as the Board of Directors in the capacity of the Secretary; the Treasurer; Directors/Officers (one or more). These officers are selected according to their ability, trustworthiness, faithfulness, and spiritual and moral conduct and shall be called the Board of Directors. Any and all major decisions concerning the church and its welfare are carried by a vote of the majority of the Board of Directors. The President/Pastor is solely responsible for appointing others, on an annual basis, to positions, i.e., the Choir, Usher's Board, Deacon's Board, Mother's Board, etc.**
