

The articles of incorporation for this organization are amended as follows:

Article 3 is amended to add:

Said organization is organized exclusively for charitable, educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (C)(3) of the Internal Revenue Code or corresponding section of any future federal tax code

Article 8 is added to read:

Upon the dissolution of the organization, assets shall be distributed as determined by the Boy Scouts of America, a 501 (c) (3) organization for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.
