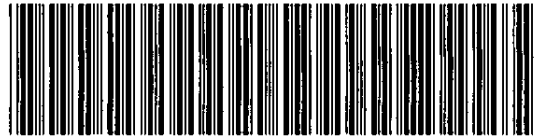





ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I... NAME

The name of the corporation shall be:

Revelation Ministries-Global Fellowship, Inc.

ARTICLE II... PRINCIPAL OFFICE

The principal street and mailing address of the corporation is:

34935 Fun Way, Zephyrhills, Florida 33541.

ARTICLE III... PURPOSE

The purpose for which the corporation is organized is:

1. To encourage and promote the Christian evangelism of the world.
2. To encourage and promote the worship of God.
3. To encourage and promote the edification of Christian believers.
4. To provide the basis for fellowship among Christians of like-precious faith.
5. To establish and maintain such sub-divisions, departments and institutions as may be necessary for the propagation of the Gospel of Jesus Christ, and the work of the fellowship.
6. To establish Churches and provide for their development.
7. To examine candidates for the ministry and to ordain as ministers those who shall meet the standards set forth in Scripture (1 Tim. 3:1-7, Titus 1:5-9), and the requirements set forth in the Constitution and By-Laws, and as the Board of Directors deems fitting and necessary.
8. To approve all Scriptural teachings, methods and conduct, and to disapprove all unscriptural teachings, methods and conduct.
9. To choose and approve it's own officers and committees, to arrange for it's own meetings, and to govern itself.
10. Incidental to or in connection therewith, to exercise the right to own, hold in trust, use, sell, convey, mortgage, lease or otherwise dispose of such property, real or personal, as may be needed for the prosecution of it's Religious, Charitable and Educational work.

ARTICLE IV... MANNER OF ELECTION

1. Administrator

In keeping with Scriptural standards and teachings, the Administrator, who shall also be known as the Senior Pastor/Presbyter/Bishop of this Religious-Charitable-Educational non-profit corporation, shall remain in office as long as he maintains a scriptural standard of teaching, living and conduct, as reviewed and judged by the members of the Board of Directors.

2. General Secretary

The General Secretary of the corporation will be initially appointed by the Administrator, and be reviewed yearly by the Board of Directors. In the event of the death, resignation or scriptural removal of the General Secretary, the remaining members of the Board of Directors shall appoint a new candidate for the office, in keeping with scriptural guidelines for the demonstration of Christian character and service to the Church, and fulfill the scriptural qualifications for Christian Ministry and Eldership (Article III, #7).

3. Treasurer

The Treasurer of the corporation shall be initially appointed by the Administrator, and be reviewed yearly by the Board of Directors. In the event of the death, resignation or scriptural removal of the Treasurer, the remaining members of the Board of Directors shall appoint a new candidate for the office, in keeping with scriptural guidelines for the demonstration of Christian character and service to the Church, and fulfill the scriptural qualifications for Christian Ministry and Eldership (Article III, #7).

4. Additional Members of the Board of Directors

The existing initial Board of Directors of 'Revelation Ministries-Global Fellowship, Inc.', shall at its discretion, and as deemed fitting and useful by the same, appoint other members to the Board of Directors at any time. Any additional candidates must also fulfill the scriptural qualifications as set forth for Christian Ministry and Eldership (Article III, #7).

ARTICLE V... INITIAL DIRECTORS AND/OR OFFICERS

1. Administrator

The Administrator of 'Revelation Ministries-Global Fellowship, Inc.' is **Dr. Thomas R. Marino**, also being known as the Founder, Sr. Pastor, Presbyter and Bishop of the same.

2. General Secretary

The General Secretary of 'Revelation Ministries-Global Fellowship, Inc.' is **Rev. Mary Ann Marino**.

3. Treasurer

The Treasurer of 'Revelation Ministries-Global Fellowship, Inc.' is **Rev. Gordon L. Buley**.

ARTICLE VI... NON-INUEMENT PROVISION

No part of the net earnings of the non-profit corporation shall inure to the benefit of any member, trustee, director, officer, or any private individual (except that reasonable compensation may be paid for services rendered to or for the organization/corporation) , and no member, trustee, officer or private individual shall be entitled to share in the distribution of any assets upon dissolution of the organization/corporation.

ARTICLE VII... RESTRICTIVE LEGISLATION PROVISION

No substantial part of the activities of the organization/corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code 501(h)), or participating in or intervening in any political campaign on behalf of any particular or specific candidate for public office.

ARTICLE VIII... RESTRICTIVE PURPOSES AND ACTIVITIES PROVISION

Notwithstanding any other provision of these articles, the organization/corporation is organized exclusively for the following purposes: Religious, Charitable, and Educational, as specified in section 501(c)(3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) or corresponding provisions of any subsequent Federal tax laws.

ARTICLE IX... DISSOLUTION

In the event of dissolution, all of the remaining assets and property of the organization shall after necessary expenses thereof be distributed to such organizations as shall qualify under section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any subsequent federal tax laws; or to the federal government, or to a state or local government for a public use. It shall be clearly understood that first consideration shall be given to those organizations that most closely adhere to the purpose and intent for which this organization was originally formed, and who most closely adhere to the statement of fundamental truths held dear by this Church organization, and who shall also qualify under section 501(c)(3) of the IRS Code, or any other subsequent tax laws.
