Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I – NAME

Qalam Ar-Rahmah, Inc.

ARTICLE II – PRINCIPAL OFFICE

2508 SW 35th Place, Unit S-113, Gainesville, FL 32608, USA

ARTICLE III – PURPOSE

To provide financial help and to promote and provide educational and vocational programs to underprivileged women and children, especially girls, in Central and Southeast Asia with contributions collected through this corporation.

This organization is organized exclusively for charitable and educational purposes under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the first paragraph of Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation set forth in the first paragraph of Article III hereof.

ARTICLE IV – MANNER OF ELECTION

Directors and Officers shall be appointed by the Executive Board Members keeping in mind that the desirable candidates share the same values and mission purpose of the corporation and that they have the experience and background to handle such responsibility. The future members of the Executive Board shall be nominated by invitation by the current Executive Board members.

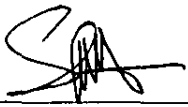

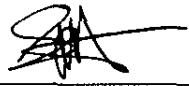
