ARTICLE III

The specific purpose for which this corporation is organized is exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any future United States Revenue Law. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by any organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code. This corporation will carry out this purpose by providing financial support to under privileged youth to allow participation in a recreational football and cheerleading program through donations, gifts and contributions from the general public. This corporation shall further carry out this purpose by educating youth in the skills and techniques of football and further develop the skills and techniques of cheerleading while providing a safe playing environment for athletic competition. The period of duration of this corporation is perpetual unless dissolved according to law. Subject to the limitations applicable to Section 501(c)(3) organizations, the corporation shall have the general powers set forth by Section 617.0302, Florida Statutes.

ARTICLE IV

The method of election of the Board of Directors is as stated in the bylaws. This corporation is a non-membership organization.
