ARTICLE I NAME

The name of the corporation is, HELPING KIDS ACHIEVE GOALS, INCORPORATED. Hereinafter referred to as "HKAG"

ARTICLE II PRINCIPAL OFFICE

The principal place of business 4801 12th Avenue South, St. Petersburg Florida 33711 and mailing address of "HKAG" shall be P.O. Box 16661- St. Petersburg, Fl. 33733, which is located in the city of St. Petersburg, County of Pinellas, State of Florida.

ARTICLE III PURPOSE

The primary purposes of "HKAG" organized exclusively for charitable purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code are: to serve as a channel through which youth regardless of age, sex, race, color, religion or creed, ranging from a low to moderate income level households have an opportunity to be provided the necessary SAT/ACT educational study skills and testing.
