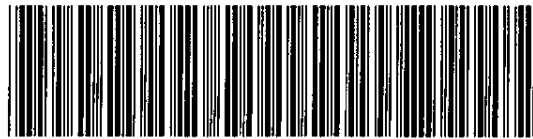

Articles of Incorporation

In Compliance with Chapter 617, F.S. (Not for Profit)

Article I

RealRhetoric.com Inc.

Article II Principal Office

133 N.E. 2nd Avenue, Miami Florida, 33132
Unit 1507

Article III Purpose

RealRhetoric.com Inc. is organized exclusively for EDUCATIONAL purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under the 501(c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax code. It shall be the purpose of the organization to exercise its mission in citizen journalism by maintaining a website featuring and depicting textual, audio, and video content created by young professionals between the ages of 20-40 participating involved in a wide spectrum of industries. The young professional will contribute both liberal and conservative perspectives on contemporary issues in socio-political, economic, technological, and environmental issues. The information contained in RealRhetoric.com Inc. shall be educational and beneficial to individual site browsers, national and local media-journalism, students, and many other communities as it will expose them to the intellectual viewpoints and perspectives of young professionals. The website shall also stream video and display images related to its educational focus. RealRhetoric.com Inc. will host on its website, forums for public discussion and discourse on contemporary socio-political, economic issues, technological, and environmental issues as well as participate in the live forums of such nature where appropriate and fitting to the corporation's purpose. RealRhetoric.com shall publicly promote its educational focus and mission worldwide.

RealRhetoric.com Inc. may receive and administer funds for, educational, and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and to that end, the Corporation is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purposes of the Corporation, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of the Corporation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Not-for-Profit Corporation Law.

No part of the net earnings of RealRhetoric.com Inc. shall inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the Corporation shall not participate in or intervene in, including the publication or distribution of statements of any political campaign on behalf of any candidate for public office. Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to one or more charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the local court of the county or state in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IV Manner of Election

RealRhetoric.com Inc. may, but need not, have voting members, and such membership, if any, and classes thereof, shall be as defined in the corporation's bylaws. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. Directors are appointed by the founder.

Article V Dissolution

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a local Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.




