# SECTION 4: Advisory Officers

The advisory officers are chosen to serve the corporation and therefore shall act in an advisory capacity with the executive officers in all matters pertaining to the corporation in its spiritual life and in the ministry of ordinances. They shall act in the examination of applicants for membership and in the administration of the discipline.

# ARTICLE VII: Nomination and Election

# SECTION 1: Procedure - Executive

All candidates for executive office shall be elected at the first business meeting, and shall serve an indefinite period of time. The directors named as the initial board of directors shall constitute a quorum for the dection of executive officers. Only the remaining initial board of directors shall have nominated any successors to an executive office, until all have been retired. All successors shall be chosen from the membership of the advisory council. All candidates shall be elected by a minimum of 80% of the initial executive officers.

THIS SECTION STANDS UNLESS CHANGED BY A BY-LAW DULY ADOPTED BY THE EXECUTIVE OFFICERS.

# SECTION 2: Procedure - Advisory Council

All candidates for the advisory office shall be nominated by the executive officers at the business meeting, or whenever a special meeting is called. They shall be elected by two-thirds vote by the executive officers. The tenure of office for the advisory officers shall be two years.

### **SECTION 3: Vacancies**

## (A) President

In the event of the vacancy in the office of the president, the vice-president shall fulfill his office. Here shall be given thirty days to call an executive meeting in which a successor is elected.

# (B) Other Executive Officers

1. In the event of a vacancy of any other executive office, it shall be filled by two thirds vote of initial executive board until all have been retired.
