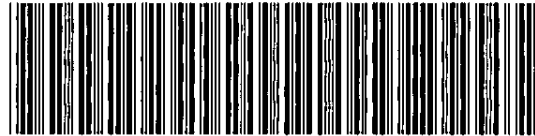

**ARTICLES OF INCORPORATION  
OF  
HOLY SMOKES NICARAGUA, INC.**  
(In Compliance with Chapter 617, F.S., (Not for Profit))

**ARTICLE 1  
NAME**

The name of the corporation shall be HOLY SMOKES NICARAGUA, INC.

**ARTICLE 2  
PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
Carretera Viejo Leon, Km. 11.5, Condominium Allyson # 13, Managua, Nicaragua

**ARTICLE 3  
PURPOSE**

The corporation shall be operated exclusively as a non-stock, non-profit charitable organization for the following purposes:

(a) To develop and administer programs designed to assist Central American people with various medical and nutritional needs.

(b) To develop and administer feeding programs, clinics, and nutritional education curriculum, designed to assist rural Central American communities to address routine nutritional and health issues.

(c) To have and to exercise to the extent necessary or desirable for the accomplishment of any of the aforesaid purposes, and to the extent that they are not inconsistent with the charitable purposes of the Corporation, any and all powers provided by Chapter 617, F.S., the Florida Not For Profit Corporation *Act*.

**ARTICLE 4  
MANNER OF ELECTION**

The qualifications for membership and the manner of appointing directors shall be regulated by the bylaws of the corporation.
