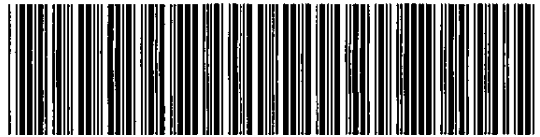

ARTICLE I - NAME Effective Date *Apr. 18, 2008*

The name of this Corporation shall be: **SW FLORIDA WOODWORKERS GUILD, INC.**

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
