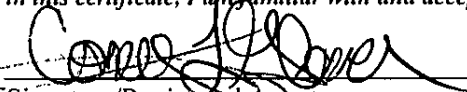

**ARTICLE III- PURPOSE**

2000 APR 21 P 2: 16

1. Phileo Outreach Ministries, Inc.'s purpose is to serve our fellow man by meeting his needs spiritually, socially, and physically as exemplified in the Word of God. The word "phileo" is a Greek word meaning "brotherly love" and therefore correctly defines the purpose of this community outreach arm of the Hallandale Beach Church of Christ.
