ARTICLES OF INCORPORATION
FOR PENSACOLA FEDERATION OF COLORED WOMEN'S CLUBS, INC.

The undersigned hereby form a Corporation under the Nonprofit Corporation Code of the State of Florida:

ARTICLE I

The name of the Corporation shall be Pensacola Federation of Colored Women's Clubs, Inc., hereinafter called the Corporation.

ARTICLE II

The principal place of business of the Corporation is 423 North C Street, Pensacola, Florida, 32501 (Escambia County). The mailing address for the Corporation is c/o 3190 Belle Christiane Drive, Pensacola, FL 32503.

ARTICLE III

The nature of the activities to be conducted and the purposes to be promoted or carried out by the Corporation shall be exclusively charitable, social service and educational within the meaning of Section 501(c) 3 of the Internal Revenue Code of 1986, (the Code), and for such purposes the Corporation may engage in any lawful act or activity for which a Corporation may be organized under the Nonprofit Corporation Code of the State of Florida in furtherance of the foregoing:

The purpose of the Corporation is to associate the African American women's clubs in Escambia County through aid, development, training and supervision; to promote civic, educational, religious, moral, social, and economic advancement of all through the uplift of African American youth, families, and senior citizens; and to cooperate with other public and private organizations to advance health, economic, and education issues that positively affect and advance the African American community.

ARTICLE IV – MANNER OF ELECTION

The Corporation shall have no members, and the care, control and disposition of its property and funds and the general management of its affairs shall be vested in its Board of Directors, which shall be elected in accordance with its bylaws. The initial Board of Directors shall be composed of nine (9) members, whose names and addresses are as follows:

ARTICLE V

The Corporation is nonprofit and shall not have or issue shares of stock or pay dividends.

ARTICLE VI

No part of the property or net earnings of the Corporation shall inure to the benefit of or be distributable to the Corporation's directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Paragraph 2 hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE VII

The duration of the Corporation is perpetual.

ARTICLE VIII

Upon any dissolution or termination of the existence of the Corporation, all of its property and assets shall after payment of the lawful debts of the Corporation and the expenses of its dissolution or termination, be delivered, conveyed and paid over to one or more charitable, scientific or educational organizations located in the State of Florida and qualified as exempt organizations under Section 501(c)3 of the Code, and described under Section 170 (c)(2) of the Code, in such proportions and for such exclusively charitable, scientific or educational purposes as the Board of Directors may determine.

ARTICLE IX

Reference in these Articles of Incorporation to sections of the Code shall be deemed to include references to the corresponding provisions of any future amendments to the Code and to the corresponding provisions of any future United States Internal Revenue Law.

ARTICLE X

The address of the initial registered and principal office of the Corporation is 423 North C Street, Pensacola, Florida 32501 and the mailing address and initial registered agent of the Corporation is Beverly Baines, c/o 3190 Belle Christiane Drive, Pensacola, FL 32503.

ARTICLE XI

The Articles of Incorporation of the Corporation may be amended by the affirmative vote of two-thirds of the directors of the Corporation then in office; provided, however, that no amendment maybe made which would cause the Corporation to no longer be qualified as an exempt organization described in section 501(c)(3) of the Code.
