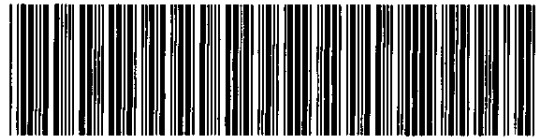

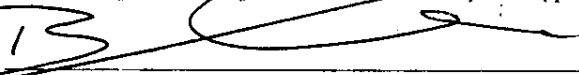

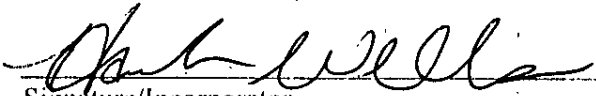

Article III Purpose

The purpose for which the corporation is organized:

To provide a service to the underprivileged members of the community of Freeport and surrounding areas. Empty Stocking Fund of Freeport was formed in 2006 to assist members of our community at Thanksgiving, Christmas, and to provide free events to all the members of the community. A free meal was provided and delivered to twelve families. It was such a success that it was decided that we would try to provide Christmas dinner and gifts for the families. In 2007, we provided thirteen families with Thanksgiving dinner and twenty-five families, a total of sixty-six children, with Christmas dinner and gifts. We also held a Fall Festival in October and provided a free night of fun for over 600 children with their families. In 2008, we held an Easter Egg Hunt/Spring Festival that included over 4500 Easter Egg Hunt, a free meal, and many games. It is our goal for the year 2008 to provide fifty families with Thanksgiving dinner and Christmas and to provide and to provide more free events for the entire community.
