ARTICLES OF INCORPORATION FOR A NOT FOR PROFIT CORPORATION OF

NORTHEAST PENSACOLA WILDCATS FOOTBALL, INC.

The undersigned subscribers to these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a not-for profit corporation under the laws of the State of Florida.

ARTICLE I

The name of the not for profit corporation is **NORTHEAST PENSACOLA WILDCATS FOOTBALL, INC.** (hereinafter referred to as the Corporation).


