

The undersigned, desiring to form a non-profit corporation pursuant to Florida Statutes Chapter 617, the Florida Not For Profit Corporation Act, for charitable and humanitarian purposes, do hereby adopt the following Articles of Incorporation:

ARTICLE I

<u>NAME</u>

The name of this Corporation is Aid For Haiti, Inc.

ARTICLE II

DURATION

Corporate existence shall commence on the date these Articles of Incorporation are filed with the Secretary of State of the State of Florida and the duration of the Corporation shall be perpetual.

ARTICLE III

ADDRESS

' ARTICLE IV

PURPOSE

This Corporation is organized and shall be operated exclusively for religious, charitable, scientific, testing for public safety, literary, or educational purposes, or to foster national or international amateur sports competition (but only if no part of its activities involve the provision of athletic facilities or equipment), or for the prevention of cruelty to children or animals, as defined by section 501(c)(3) of the Internal Revenue Code of 1986 and the Regulations promulgated with respect thereto as amended from time to time, and including the making of distributions to exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986.

ARTICLE V

PROHIBITION AGAINST PRIVATE BENEFIT

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or

the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE VI

DISPOSITION UPON DISSOLUTION

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or any corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of Broward County, Florida consistent with the purposes of the corporation as said Court shall determine.
