**ARTICLES OF INCORPORATION
OF
CONSERVATIVE REPUBLICAN ALLIANCE INC.**

The undersigned, a natural person of the age of eighteen years or more, acting as the sole incorporator of a corporation under the provisions of the Florida Not for Profit Corporation Act (the "Act"), adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Conservative Republican Alliance Inc.

ARTICLE II

The street address of the initial principal office of the corporation is 20400 West Country Club Drive, Suite 118, Aventura, Florida, 33180.

ARTICLE III

(a) The primary purposes of the corporation are (1) to work towards the promotion of conservative values through a public education program and a lobbying program directed at state and federal legislatures, executive officers and governmental agencies, and (2) to support the lobbying program through appropriate research, through education of the public regarding methods of political influence, and through fundraising efforts for such purposes.

(b) The general purposes and powers of the corporation are to have and exercise all rights and powers conferred on not for profit corporations under the laws of the State of Florida, including the Act, or which may hereafter be conferred, including the powers to contract, rent, and buy or sell personal or real property; provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

(c) Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(4) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.

ARTICLE IV

The election of directors shall be as stated in the bylaws of the corporation.

ARTICLE V

The street address of the corporation's registered office is 20400 West Country Club Drive, Suite 118, Aventura, Florida, 33180, and the name of the corporation's registered agent at that address is Javier Manjarres.

ARTICLE VI

The number of directors constituting the board of directors of the corporation shall not be less than three. The number of directors constituting the initial board of directors shall be three. From time to time hereafter, the number of directors shall be fixed exclusively pursuant to a resolution adopted by the affirmative vote of a majority of the board of directors of the corporation.

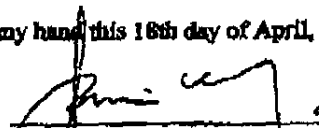
