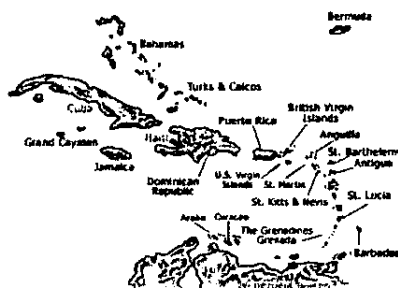

**Articles of Incorporation
of
HELPING CHILDREN WORLDWIDE CENTER INC.
A Non-Profit Corporation**

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

Article 1

The name of the corporation shall be: **HELPING CHILDREN WORLDWIDE CENTER INC.**

Article 2

The principle office of the corporation for the transaction of its business is located at 1247 North Pine Hills Road, Orlando, Florida 32808

Article 3

The purpose for which this corporation acting as a private foundation will function and operate as a 501 c 3 nonprofit incorporation that will develop facilities, programs and raise funding for the sole purposes of helping to feed, clothe, educate and provide prevention, intervention and treatment medical care to children worldwide. The primary region of the world in which the Helping Children Worldwide Center Inc has identified to devote and provide its primary attention and resources are to children in distress and need that lives on the Caribbean Islands, with Haiti, the Dominican Republic and Puerto Rico as the starting islands to conduct its initial operations. The Helping Children Worldwide Center Inc will also seek and build collaborative partnerships with other similar minded philanthropic individuals and groups, foundations, corporations and governments who support the care of children.

**Article 4
Stock Shares**

There are no stock shares available.

Article 5

The manner in which the directors are elected or appointed:

The Board of Directors is that group of persons vested with the management of the business affairs of this Corporation subject to Florida law, the Articles of Incorporation, and these bylaws. The Board of Directors may delegate the management of the day-to-day operation of the business of the Corporation to committees, staff or the Executive Director (if applicable); provided that the activities and affairs of the Corporation shall be managed and all corporate powers shall be exercised under the ultimate direction and authority of the Board of Directors.

Directorships shall not be denied to any person on the basis of race, creed, sex, religion, or national origin. Each director shall be an individual at least eighteen (18) years of age. The Board of Directors shall appoint the members of the Board of Directors in accordance with procedures set forth in these bylaws. The Board of Directors will consist of not less than Five (5) or more than twenty-five (25) directors. The number may be fixed by resolution as provided in the Bylaws.
