

No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from the federal tax code, or (b) by an organization, contributions to which are deductible under section 170 c 2 of the Internal Revenue Code, or corresponding section of any future tax code.
