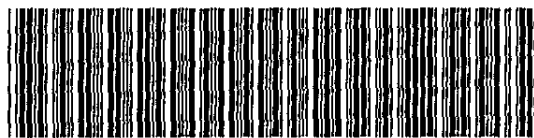

The undersigned incorporator to these Articles of Incorporation does hereby form a corporation not for profit under the provisions of Florida Statutes Chapter 607.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be the ANGLICAN DIOCESE OF FLORIDA, INC.

ARTICLE II - PURPOSE

The purpose of this Corporation shall be to assist other affiliated churches in the promulgation of the Anglican religion; to help establish new Anglican churches in Florida; and to preach the gospel.

ARTICLE III - PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be 3066 Drew Way, Palm Springs, Florida 33406.

ARTICLE IV - TERM OF EXISTENCE

The corporate existence of the corporation shall commence as of the date and time upon which these Articles of Incorporation are filed with the Florida Department of State.

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE V - MANNER OF ELECTION OF DIRECTORS

The directors of the corporation shall be elected pursuant to the By-Laws of the corporation. The initial directors shall serve until the initial meeting of the members of the corporation have adopted the By-Laws of the corporation. The number of directors shall be at least three persons, but may be increased from time to time as provided in the By-Laws of the corporation.
