Articles of Incorporation of CUAM COMMUNICATIONS, INC.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to provide cultural services such as "Classic Films Repertory Programs ("CINECLUB 24", on its 4th. year of operation) and AV services(video coverage, audio recordings, photographic services and video documentation of artist's oral histories) to artists, other-non profit cultural institutions and the Miami Dade County Community..
