# ADDENDUM 1 TO AMENDMENT OF ARTICLES OF INCORPORATION

- A. This corporation is organized and operated exclusively for religious purposes within the meaning of Sections 501(o)(3) of the Internal Revenue Code.
- B. We substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- C. The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its exsets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a compress fund, foundation or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt some under Section 501(a)(3).
