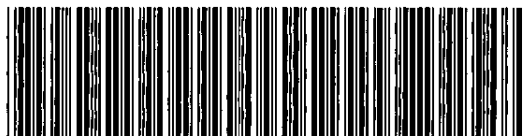

ARTICLES OF INCORPORATION

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Incorporation., under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

Article I: The name of the Incorporation shall be **Citizens with Criminal Backgrounds, Inc.**

Article II: The place in this state where the principal office of the Incorporation will be located is: **8343 Hogan Road, # 142, Jacksonville, Florida 32216;**
