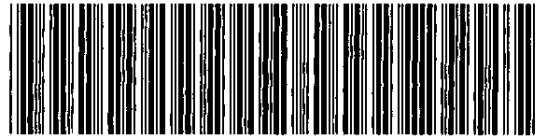

**ARTICLES OF INCORPORATION
OF
POWER FROM ON HIGH OUTREACH MISSION, INC.
A Florida Corporation Not for Profit**

The undersigned incorporator to these Articles of Incorporation, desiring to form a perpetually existing corporation not for profit pursuant to Chapter 617, Florida Statutes, as amended.

ARTICLE (1). NAME

The name of the corporation shall be known as **Power From On High Outreach Mission, Inc.**

ARTICLE (2). PRINCIPAL MISSION

The address of the principal mission meeting place of **Power From On High Outreach Mission, Inc.** is 5410 N.W. 14th Avenue, Miami, Florida 33142 and the mailing address is 5410 N.W. 14th Avenue, Miami, Florida 33142.

ARTICLE (3). PURPOSE(S)

Section 1. **Power From On High Outreach Mission, Inc.** is organized as an Outreach Mission and Community Development Outreach which is operated exclusively religious, charitable, scientific, literary, and educational purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code of 1986, 1999 or the corresponding provision of any future United States Internal Revenue Law.

Section 2. **Power From On High Outreach Mission, Inc.** is organized for engaging in charitable, vocational and educational purposes to aide disenfranchised men and families toward a life of self sufficiency. **Power From On High Outreach Mission, Inc.** consist of, but shall not be limited to: National and International Seminars and Workshops, Intergeneration Christian and Spiritual Ministry, Intergenerational Outreach Advocacy programs for the Disadvantaged, Literacy of Adults and Seniors, Educational enhancements for school of aged children through a structured after-school care program and Early Childhood Educational Programming, 24 Hour Child Care Programming, Structured Programs for Adults and Seniors for educational and vocational purposes, Cultural Arts, Arts and Crafts, Alternative Vocational Specialties, Entrepreneurial Skills, Counseling, Teenage Pregnancy Prevention, Job Training, Job Placement, and Acquisition, Housing, Homelessness, Clothing and Feeding, Community Development Projects, Referral and Networking Facilitation Projects, Substance Abuse, Foreign and Domestic Missions and other Programs to aide those in need.

ARTICLE (4). POWERS

Except as limited by these Articles of Incorporation or its by-laws, **Power From On High Outreach Mission, Inc.** shall have and exercise all rights and powers in furtherance of its purposes as are now or may hereafter be conferred on not-for-profit corporations pursuant to Chapter 617, Florida Statutes and other applicable law.

ARTICLE (5). LIMITATIONS ON ACTIVITIES

Section 1. **New Life Outreach Mission** is not for a private gain. No part of the net earnings of **Power From On High Outreach Mission, Inc.** shall inure to the benefit of, or be distributed to its members, trustees, officers, or other

private persons, except that **Power From On High Outreach Mission, Inc.** shall be authorized and empowered to pay reasonable compensation for services rendered. To make payments and distributions in furtherance of the purposes set forth in this article.

Section 2. No substantial part of the activities of **Power From On High Outreach Mission, Inc.** shall be the carry on of propaganda. Otherwise attempting to influence legislation and **Power From On High Outreach Mission, Inc.** shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any part of these articles.

Section 3. **Power From On High Outreach Mission, Inc.** shall not carry on any other activities not permitted to carry on. (A) By a corporation exempt from federal income tax under Section 501(C) (3) of the Internal Revenue Code, or the corresponding section of any future federal income tax code. (B) By a corporation, contributions to which are deductible under Section 170(C) (2) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE (6). DISSOLUTION

Power From On High Outreach Mission, Inc. Dissolution of Assets, upon the dissolution or winding up of **Power From On High Outreach Mission, Inc.**, its assets remaining after payment or provision for payment of all debts and liabilities of **Power From On High Outreach Mission, Inc.**, shall be distributed to **Power From On High Deliverance Ministry, Inc.** which the church has established its tax exemption status under Section 501(C)(2) and 170(C)(2) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws. If not established assets shall be distributed to the Federal Government, or to a State or Local Government, for public purpose.

ARTICLE (7). INCORPORATOR (S)

The name and street address of the incorporator(s) of **Power From On High Outreach Mission, Inc.** is:

ARTICLE (8). TERMS OF EXISTENCE

Power From On High Outreach Mission, Inc. shall have perpetual existence as a nonprofit mutual benefit corporation, unless dissolved according to law.

ARTICLE (9). BOARD OF DIRECTORS

Section 1. The business and affairs of **Power From On High Outreach Mission, Inc.** shall be managed by:

Elder Robert L. McDuffie, Jr. Executive Director

Section 2. The names and addresses of the persons who are to serve as Directors of **Power From On High Outreach Mission, Inc.** are:

Pastor Barbara McDuffie, Director
Brother Fred Walton, Director

Whose addresses shall be the same as the principal office of **Power From On High Outreach Mission, Inc.**

Section 3. The number of Directors of **Power From On High Outreach Mission, Inc.** shall be not less than three. Subject to the foregoing, the number of Directors may be increased or diminished from time to time by the By-Laws of the Corporation.

Section 4. Directors shall be elected, removed and hold office as provided in the by-laws.

ARTICLE (10). OFFICERS

Section 1. The officers of **Power From On High Outreach Mission, Inc.** shall include a President, a Vice President, a Secretary, a Treasurer and other officers as designated in the by-laws. The same individual may simultaneously hold more than one office.

President: Elder Robert L. McDuffie, Jr.
Vice President: Pastor Barbara McDuffie
Secretary: Chiquitta Johnson
Treasurer: Pastor Barbara McDuffie

Section 2. The officers shall have such powers and responsibilities and shall be elected, removed and hold offices as provided in the by-laws.

ARTICLE (11). NON-STOCK CORPORATION

Power From On High Outreach Mission, Inc. shall not have or issue shares of stock. It may have and issue membership certificates that shall state prominently on the face of such certificate that such certificates are not transferable and that **Power From On High Outreach Mission, Inc.** is a not-for-corporation.

ARTICLE (12). MEMBERSHIP

The Membership of **Power From On High Outreach Mission, Inc.** shall be open to all persons regardless of race, color, creed, sex, or national origin and shall initially only consist of voting members, which shall include the persons constituting the Board of Directors and such additional persons as they may by majority vote from time to time elect.

The qualifications for membership and manner of admission shall be govern and regulated by the by-laws of **Power From On High Outreach Mission, Inc.** The by-laws may also provide for additional classes of Members.

ARTICLE (13). LIABILITIES FOR DEBTS

Neither the members nor the members of the Board of Directors or officers of **Power From On High Outreach Mission, Inc.** shall be liable for the debts of **Power From On High Outreach Mission, Inc.**

ARTICLE (14). REGISTERED OFFICE AND REGISTERED AGENT

Section 1. The initial address of registered office of **Power From On High Outreach Mission, Inc.** is 5410 NW 14th Avenue, Miami, Florida 33142.

Section 2. The name and address of the registered agent of **Power From On High Outreach Mission, Inc.** is Elder Robert Lee McDuffie, Jr., located at 5410 N.W. 14th Avenue, Miami, Florida 33142.

ARTICLE (15). BY-LAWS

The power to adopt, alter, amend or repeal by-laws for **Power From On High Outreach Mission, Inc.** shall be vest only in the Directors, as more specifically provided in the by-laws.

ARTICLE (16). AMENDMENT

These Articles of Incorporation of **Power From On High Outreach Mission, Inc.** may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the Members, and approved at a Members meeting by a majority of the Members, unless all the Directors and all the Members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
