

**AMENDED ARTICLES OF INCORPORATION  
FOR ROBINSON IB LINK, INC.**  
(AS APPROVED MARCH 10, 2009)

**A FLORIDA NONPROFIT CORPORATION**

**ARTICLE I – NAME**

The name of this Corporation is Robinson IB Link, Inc.

**ARTICLE II – PRINCIPAL PLACE OF BUSINESS & MAILING ADDRESS**

The principal office and mailing address of the corporation shall be 6311 South Lois Ave., Tampa, FL 33616.

**ARTICLE III – PURPOSE**

**SECTION ONE:** The purpose of this Corporation shall be:

1. To develop and support initiatives that improves and enhances students' International Baccalaureate experience at Robinson High School in Tampa, FL, which is an organization described in Section 501(c)(3) of the Internal Revenue Code;
2. To bring into closer relation home and school, that parents, teachers, and faculty may cooperate in the education of students, and
3. To develop between Robinson IB and the general public such united efforts as will secure for all students the highest advantages in mental, physical, and social education.

**SECTION TWO:** The purposes of RIBLI are promoted through an advocacy and educational agenda directed toward parents, teachers, faculty, and the general public; developed through committees, projects, and programs; and governed and qualified by the basic policies set forth in Article III.

**SECTION THREE:** The Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, and pursuant to the Florida Corporations Not For Profit Law set forth in Section 617 of the Florida Statutes.

**ARTICLE IV – BOARD OF DIRECTORS: MANNER OF ELECTION**

**SECTION ONE: ORGANIZATION MANAGEMENT** - The affairs of the Corporation shall be managed by the board of directors, consisting of not less than five (5) nor more than 15 members.

**SECTION TWO: BOARD MEMBERSHIP** - The members of the board of directors shall be the president, president-elect, treasurer, secretary, and as appropriate, two (2) members representing 9<sup>th</sup> grade, two (2) members representing 10<sup>th</sup> grade, two (2) members

representing 11<sup>th</sup> grade, two (2) members representing 12<sup>th</sup> grade, and up to three (3) at-large members.

**SECTION THREE: ELECTION** – Board members shall be elected by a majority vote by the members of the organization present at the annual meeting.

**SECTION FOUR: TENURE** - Board terms shall be in effect for one (1) fiscal year. Board members may be recommended to serve three (3) additional one-year terms.

**ARTICLE V – INITIAL DIRECTORS AND/OR OFFICERS**

The directors named herein shall hold office until the first meeting of members at which time an election of directors shall be held as regulated by the Bylaws of the Corporation:

**ARTICLE VI – MEMBERSHIP**

The qualification for members and the manner of their admission shall be regulated by the Bylaws of this Corporation.

**ARTICLE VII – DISSOLUTION OF ASSETS**

Upon the dissolution of this Corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to one or more nonprofit funds, foundations, or organizations that have established their tax-exempt status under Section 501(c)(3) of the Internal Revenue Code and whose purposes are in accordance with the Corporation.

**ARTICLE VIII – LIMITATIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be

authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

**ARTICLE IX – INITIAL REGISTERED AGENT & STREET ADDRESS**
