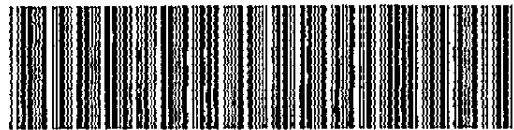

**ARTICLES OF INCORPORATION  
FOR  
KENZIE KARE GROUP HOMES, INC.**

For the purpose of filing a not for profit corporation under Chapter 617 of the Florida General Corporation Act, the Secretary of State is respectfully requested to provide approval of such incorporation under the following Articles:

**ARTICLE I**

The name of this corporation shall be **KENZIE KARE GROUP HOMES, INC.**, and its initial principal place of business shall be 919 Fifth Avenue, Lehigh Acres, Florida, 33972, with the right to move said principal place of business and establish other places of business within or without the State of Florida as the Board of Directors may from time to time deem proper.

**ARTICLE II**

The specific purpose which this corporation is organized is to improve each individual's life with quality health care, meaningful training/work and a variety of leisure/ social opportunities in the state of Florida, notwithstanding, any activity or business with any or all purposes determined convenient or necessary by the Board of Directors as permitted under the laws of the United States and the State of Florida as may be restricted under these Articles and its Bylaws.

**ARTICLE III**

The corporation shall have perpetual existence, unless earlier terminated by due and proper legal procedure.

**ARTICLE IV**

The number of directors of said corporation shall be provided in the By-Law, but in no event shall the number be less than one (1) or more than five (5).

**ARTICLE V**

Directors shall be elected in a manner consistent with the terms of the bylaws.

**ARTICLE VI**

#### **ARTICLE VII**

In furtherance and not in limitation of powers conferred upon the Board of Directors are expressly authorized and cause to be executed, mortgages and liens upon the real and personal property of the corporation for the purposes of furniture security for its ineptness or for any other purpose. The Directors, if the By-Laws so provide, may hold board meetings within or without the State of Florida. The corporation may in its By-Laws, confer powers additional to the power and authority expressly conferred upon them by statute to the Directors.

#### **ARTICLE VIII**

The By-Laws shall set forth the manner in which amendments and revisions, including alterations of any provisions, of these Articles, and the By-Laws, shall be made.

#### **ARTICLE IX**

This corporation shall be endowed with all the corporate powers enumerated in the Florida General Corporation Act.

#### **ARTICLE X**

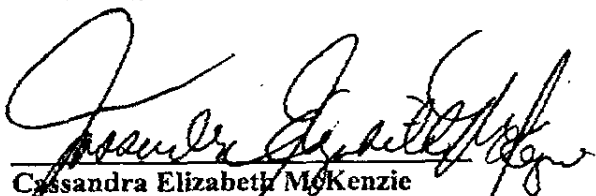
