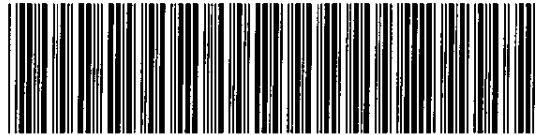

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby respectfully petition the Department of State for approval of State for approval of these Articles of Incorporation as a Not For Profit Corporation, and do hereby certify:

**ARTICLE I**

The name of the Corporation shall be called **Quality Lifestyle Enhancement Learning, Inc.**

**ARTICLE II**

The place in this state where the principle office of the Corporation is to be located is 5104 North Orange Blossom Trail Suite #110 in the City of Orlando, FL 32810; Orange County.

**Article III**

**Purpose and Objectives**

**Section 1: Purpose.** The general purpose of this corporation shall be to meet the educational needs of students and adults in the community through an after school tutoring program. Quality Lifestyle Enhancement Learning, Inc. will take a proactive approach in building individual positive self-esteem to each participant through academic tutoring and all other educational requirements that will enhance academic growth. This corporation will also provide parenting classes for parents with children that have difficulties in school and the community. There will also be Bible classes available to enhance individual spiritual growth. This organization shall be established and connected therewith of an educational, charitable and spiritual character all in a manner consistent with Section 501 © (3) of the Internal Revenue Code that will promote the advancement of youth, teens, and adults which will be qualifying as exempt organization under section 501 ©( 3) of the Internal Revenue Code. Therefore, the overall purpose of this corporation is to give back to community by providing a wealth of non-profit effective resources.

**Section 2. Objectives.** The objective of the corporation is to enhance educational, spiritual, and moral growth; to build character/self esteem, to help students receive better grades in school that will promote a strong desire for students to successfully complete high school with a diploma; to provide educational trainings that will increase a positive and more effective parenting society regardless of parent's age and gender; and to support individual spiritual growth and to provide individual and group mentoring.

## **Article IV**

### **Officers**

**Section 1. Officers** The offices of the corporation shall be a President (Director), Vice President (Assistant Director), Secretary, Treasurer, and program coordinator.

**Section 2. Election, Qualification and Term of Office:** The officers of the corporation shall be the initial Board members . Vacancies may be filled or new offices created and filled at any meeting of the Board members by the president. Each officer shall hold office until he/she resigns or his/her successor shall have been duly qualified and elected. Any two of these offices may be combined and held by one person, except that of Office of the President cannot be combined with the office of the vice –president or the office of the secretary.

**Section3. Duties of Officers:** The duties of the officers shall be such as usually attach to such offices and, in addition thereto, such further duties as may be created from time to time by the Board of Directors.

- (a) **Director:** The Director shall preside at all meetings of the Board and its committee, and shall be an ex-officio member of all regular or special committees. He/she shall perform all such duties as are incident to the office. He/she shall be responsible to the Board of Directors for developing and recommending operating policies, assisting in developing plans for present and future operations, and administering the operating account of the corporation.
- (b) **Assistant Director:** The Assistant Director shall function in the absence of the Director and shall assume all the duties and responsibilities which are ordinarily performed by the Director. He/she shall assist in planning, organizing, coordination, and carrying the program activities.
- (c) **Secretary:** The secretary shall be responsible for taking, recording and preserving the minutes of the meetings of the Board of Directors. He/she shall also be responsible for typing letters, memorandums, and other legal documents for the corporation. He/she is responsible for all scheduling. (staff meetings, classes, and tutoring)
- (d) **Treasurer:** The treasurer shall oversee the funds of the corporation and issued to the Board of Directors an annual financial statement at its annual meetings. He/she will be

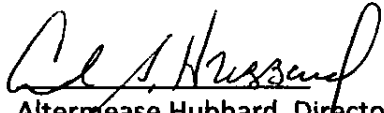
(e) Program Coordinator: The Program Coordinator shall design and organize the educational tutoring programs, parent trainings, Bible classes, etc. with the assist of the directors.

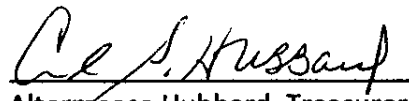

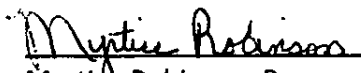
