ARTICLE I- NAME

The name of the corporation is:
St. Vincent & the Grenadines Benevolent Organization, Inc.

ARTICLE II- PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is;
18150 Coralwood Lane, Groveland, FL 34736.

ARTICLE III- PURPOSES

The corporation is organized exclusively for charitable and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV- MANNER OF ELECTION OF DIRECTORS

The manner of election of the directors shall be as stated in the by-laws.

ARTICLE V- NO PRIVATE INUREMENT

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to any of its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. The corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under 501(C)(3) of the Internal Revenue Code, or (2) by a corporation, contributions to which are deductible under 170(C)(2) of the Internal Revenue Code, or the corresponding section(s) of any future federal tax code.

ARTICLE VI- DURATION

The corporation shall continue indefinitely unless the Board of Directors terminate it and distribute all of its assets, which action maybe taken by the Board of Directors in their discretion at any time.

ARTICLE VII- DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose. If the corporation holds any assets in trust, such assets shall be disposed of in a manner as may be directed by decree of the Circuit Court of the district in which the corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.

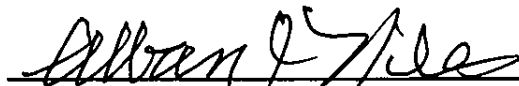

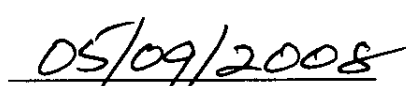
