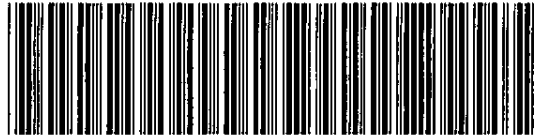





ARTICLE III PURPOSE:
