Pursuant to the provisions of section 6 J7.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

Article III - General & Specific Purposes

This corporation is organized exclusively for charitable, educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific and primary purpose for which this corporation is formed is to provide a variety of educational and charitable services in order to enable individuals to function effectively within the parameters of a free society.

This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication or distribution of any statements or otherwise in any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

All other articles remain as first written by the incorporators on May 2, 2008 and filed with the State of Florida on May 14, 2008.

This amendment was adopted by the Board of Directors on September 1, 2015.
