ARTICLE I  
CORPORATE NAME

The name of this corporation is NATIONAL ASSOCIATION OF TEACHERS OF SINGING, INC.

ARTICLE II  
PRINCIPAL OFFICE

The street address and mailing address of the principal office of this corporation is 9957 Moorings Drive, Suite 401, Jacksonville, Florida 32257.

ARTICLE III  
COMMENCEMENT OF EXISTENCE

The existence of the corporation commenced with the filing of Articles of Incorporation in the state of Illinois on April 26, 1944, a copy of which are attached hereto. On and as of the date of these Articles of Incorporation being filed, this Corporation shall no longer be domesticated in Illinois, and shall instead be domesticated in Florida. The corporation shall have perpetual existence.

ARTICLE IV




