ARTICLES OF INCORPORATION

for

ARTICLE I

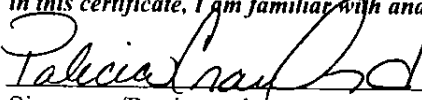

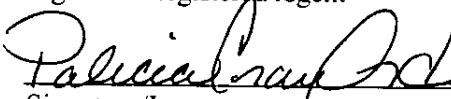
