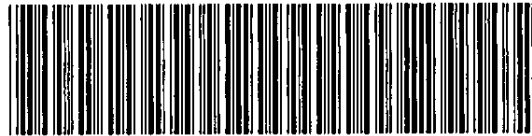

Article III- Purpose:

The purpose for which the corporation is organized is: to provide character education and to enrich the lives of children and teens, to enhance the growth and development of children and teens, and to perform such other activities allowable by law to be performed by corporations not-for-profit as may be further defined from time to time in the By-Laws or by resolution of the Board of Directors and/or Members. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of an future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located (CONTINUED ON ATTACHED)


