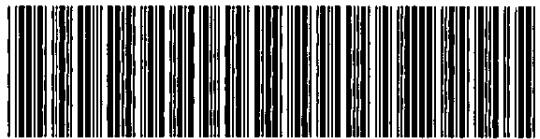

The name of the corporation shall be The Gospel Goes to Prison, Inc. as a non-profit corporation pursuant to Chapter 617, Florida Statutes (F.S.).

Article II

The principle office of this corporation is 1331 Cass Street, County of Hillsborough, and State of Florida.

The purpose(s) for which this corporation is organized and objectives are as follows:

- (a) To provide a support system for ex-offenders as they prepare to reenter into the community.
