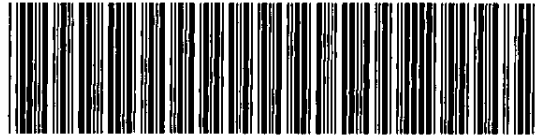


**ARTICLES OF INCORPORATION
