**ARTICLES OF INCORPORATION  
OF  
FLORIDA INTERGENERATIONAL ORCHESTRA OF AMERICA, INC.**

To further common purposes, the undersigned persons agree to organize under Articles of Incorporation.

**ARTICLE I  
NAME**

The name of this corporation shall be FLORIDA INTERGENERATIONAL ORCHESTRA OF AMERICA, INC.

**ARTICLE II  
ENABLING LAW**

This corporation is organized pursuant to the Corporations Not For Profit law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

**ARTICLE III  
PURPOSES**

- a. The purposes for which the organization is organized are exclusively religious, charitable, scientific, literary, and education within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 of the corresponding provision of any future United States Internal Revenue law.
- b. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the corresponding provision of any future United States Internal Revenue Law.

**ARTICLE IV  
TERM**

This corporation shall have a perpetual existence.

**ARTICLE V  
MEMBERSHIP**

Members accepted shall be those named in these articles as subscribers and those appointed for particular terms by those named in these Articles as subscribers. Those named in these Articles may be removed by a majority of subscribers of those named in these Articles. Members shall be appointed based upon ideologies consistent with these Articles, particularly music, music appreciation and education. All voting rights and other rights, interests and privileges of each member shall be equal.

**ARTICLE VI  
MANAGEMENT OF CORPORATE AFFAIRS**

(a) EXECUTIVE BOARD OF DIRECTORS. The Powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of at least three (3) executive

directors. The executive Board of Directors shall be the Members. The number of directors herein provided for may be changed by a By-Law duly adopted by the members entitled to vote of the membership.

ARTICLE IX  
BY-LAWS

By-Laws will be hereinafter adopted at the first meeting of the Board of Directors. Such By-Laws may be amended or repealed, in whole or in part, by the members in the manner provided therein. Any amendments to the By-Laws shall be binding on all members of this corporation.

ARTICLE X  
AMENDMENT OF ARTICLES

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Executive Board of Directors and presented to a quorum of members for their vote. Amendments may be adopted by a vote of at least two-thirds of a quorum of members of the corporation.

ARTICLE XI  
DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas, of the county in which the principal office of the corporation is then located, exclusively for purposed.

ARTICLE XII  
EFFECTIVE DATE

The effective date of this Corporation shall be the date as filed in the Secretary of State's Office in Tallahassee, Florida.

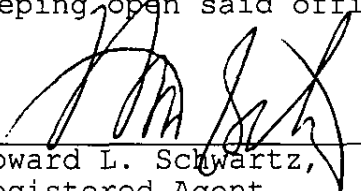

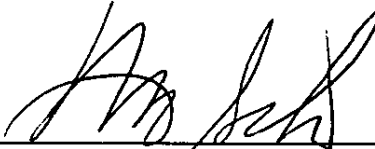
