RECITALS

WHEREAS, VISUAL ARTS CENTER ENDOWMENT TRUST, INC., a Florida corporation not for profit (the "Trust") is governed by the Charter executed on August 27, 1996, as modified on May 10, 2001, September 16, 2002, April 18, 2005, and further modified on October 15, 2007 (the "Charter"); and

<u>ARTICLE V. Section 5</u> is amended and restated in its entirety as follows:

"Section 5. SECRETARY. The Secretary position shall be comprised of two positions, the Corresponding Secretary and the Recording Secretary, both defined below:

- (a) <u>Corresponding Secretary</u>. The Corresponding Secretary shall give all notices required by law, this Charter, or as may be required from time to time by the Board, and shall perform all of those duties required by law or this Charter, or as may be defined from time to time by the Board.
- (b) Recording Secretary. The Recording Secretary shall keep minutes of all meetings of the Board, shall be custodian of the records of the Trust, and shall perform all of those duties required by law or this Charter, or as may be defined from time to time by the Board.
