ARTICLE I: The name of this corporation is Victory Outreach North Miami,

Inc.

ARTICLE II: The principle place of business is 1145 NW 125th Street, North

Miami, Florida 33168. The mailing address is P.O. Box 610187,

North Miami, Florida 33261.

ARTICLE III: This Corporation is a nonprofit religious corporation and is not

organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation law primarily for religious purposes. The specific purposes for which this corporation is organized are to operate a church for the promulgation of the gospel of Jesus Christ, the rendering of Christian service, through spiritual and educational means to those in need.
